

Job Seeker Terms and Conditions

Prior to using any service of Global Health Staff Limited (“Global Health Staff”), including but not limited to any website owned or operated by Global Health Staff, you agree to be bound by each and every one of the terms and conditions hereinafter appearing. These terms and conditions supersede any and all previous terms and conditions relating, concerning or applying to any services offered by Global Health Staff.

1. Application of these Terms

1.1. These Terms and Conditions are deemed read, understood and unconditionally accepted by the Applicant upon acceptance of these Terms and Conditions during the Registration process, or in the case of an Applicant who has not completed Registration, when the Applicant actively uses the Site for any reason.

1.2. Any breach of these Terms and Conditions may result in suspension of services provided by Global Health Staff.

1.3. The Applicant hereby irrevocably and unconditionally indemnifies and shall keep indemnified Global Health Staff from and against all losses, damages and expenses which Global Health Staff is liable or may be liable for by reason of any breach of these terms and conditions by the Applicant.

2.1. 2.2. Global Health Staff posts information provided to it by its Clients, and at all times the Applicant must satisfy himself / herself as to the bona fides, veracity and details of any position advertised on the Site or any Vacancy Advertisement appearing on the Site or accessed via the Site or links from the Site or e-mailed by Global Health Staff. 3.2. 4. Email Job Alerts

5. CV's and personal information.

5.1. All services are subject to any instructions from an Applicant. Global Health Staff will not make available to any other party any information or CV posted to the Site by the Applicant without the permission of the Applicant.

5.2. Global Health Staff has the right at its own discretion to suspend or remove any Applicant's information or CV from the Global Health Staff Site.

5.3. Any Applicant information or CV found to contain illegal, obscene, offensive or immoral material will be withdrawn by Global Health Staff until the Applicant amends or replaces the information.

5.4. A Applicant must not post a CV or other information that does not contain a true and accurate record of the Applicant's personal details, education, employment history, immigration status or training history.

5.5. Applicants who do not comply with article 6.4 may, at the discretion of Global Health Staff, have their personal details and CV removed and access to the site suspended indefinitely.

5.6. An Applicant who makes representation of any other living person, part of a person or any other copy by which any other living person can be identified is taken to have obtained the appropriate authority of that living person before posting such information to the Site.

8.4 If any provision of these Terms is held to be void or unenforceable in whole or in part, these Terms shall continue to be valid as to the other provisions and the remainder of the affected provision. No waiver by Global Health Staff shall be effective except in relation to the matter in respect it was specifically given.

8.5 Termination of these terms will not end those provisions that are capable of surviving the ending of these provisions.
